Kandla Port Trust intends to arrange in-house E-auction to dispose off unclaimed & uncleared cargo lying at this Port on the website www.kptauction.org for this purpose Registration of the Buyers is opened. The process of registration will be as under:

- (i) Auction will be open to bidders who are registered with Kandla Port Trust in advance only.
- (ii) Registered bidders will be able to access the auction site by using the user ID & password.
- (iii) The registration will be open to all persons / firms / companies which apply in the prescribed proforma to be obtained from the office of the Traffic Manager or it can be downloaded from the website.
- (iv) The duly filled application along with the required documents has to be submitted in the Office of the Traffic Manager, Shipping Section, Port & Customs Building, New Kandla – 370210.
- (v) All applications should be accompanied by a Demand Draft amounting to Rs. 5,000/- (Rupees five thousand only) in favour of 'FA&CAO - Kandla Port Trust' payable at Gandhidham / Kandla or by cash towards deposit (Refundable). The application form, Procedures and conditions of E-auctioning can be downloaded from the above website.
- (vi) The Port Trust will issue an acknowledgement, immediately to the applicant on the receipt of the application. However, confirmation of registration will be given only after receipt of hard copy of application form alongwith requisite fees.
- (vii) A Bidder Registration Card will be sent to all the applicants and user ID & password will be intimated to them.
- (viii) As soon as the use ID & password are received by the applicant, he will be required to change the 'password' in his own interest to ensure that no one else will be able to use it. The responsibility is with him to ensure secrecy of his password and if there is any misuse of this password, he will be solely responsible for any loss or damage.
- (ix) Out of Rs. 5,000/- paid at the time of application, Rs. 4,900/- will be refunded at any time on request for cancellation of registration and the applicant should surrender the Bidder Registration Card. However, in case of any dues from the bidder, Kandla Port Trust reserves the right to adjust the amount towards the dues.
